

# BUILDING CONNECTIONS. STRENGTHENING PHILANTHROPY.

2018 Annual Report

#### Dear Colleagues:

It has been another record-breaking year — both for our organization and our network.

Our staff size increased to four from two, and our 2019 budget is expected to be almost twice as big. We offered almost 90 opportunities for our members to engage, learn and network, with some participants telling us our programs are more relevant than ever. And with a total of 89 new and returning members, attendance at our annual meeting reached its highest level in at least the past decade.

Thanks to the support of our generous members, annual dues revenue climbed to a record high in 2018 and overall grant proceeds more than doubled, largely because of the commitment of ten members to fund a full-time position to build and facilitate a Rural Funders Learning Network.

We are also excited to share that the board has finalized and adopted new guidelines that will allow us to expand our reach to include several new membership categories that reflect the evolving and growing field of philanthropy.

The following pages provide more details about our leadership in convening foundations and nonprofits to explore the topic of openness, as well as our efforts to inform the field and advocate for a fair and accurate census count. Both of these initiatives received financial support from our valued national network, United Philanthropy Forum.

Our advocacy work continues to expand and we are laying the groundwork for collaboration with the many new statewide elected and appointed officials, as well as maintaining connections with our Congressional delegation to increase visibility and promote understanding about our sector.



- ▲ With input from a cohort of 12 foundation and nonprofit leaders, we published "Exploring Openness." The reflections inspired the theme for the 2018 C(3) Forum convening hundreds of professionals around the topic of strengthening relationships and providing feedback.
- ▲ We added three new peer groups—the Arts & Culture Funders Group, Information Technology Roundtable, and Rural Funders Learning Network—to help members forge meaningful connections across roles and issue areas.



## 2018 HIGHLIGHTS



- ▲ We piloted a new "two-track" program format to provide a deep dive into critical issues such as housing and the opioid epidemic, followed by time for members to connect and exchange funding strategies.
- ▲ We held two programs about Census 2020, one exclusively for funders and another one in partnership with others and designed for funders, nonprofits, community members, and business and government representatives.
- We welcomed nine new and former members—Comcast, Community Foundation of the San Luis Valley, Department of Local Affairs (DOLA), The Donor Alliance Foundation, Elevations Foundation, Great Outdoors Colorado (GOCO), PNC Bank, Southern Colorado Community Foundation, and The Telluride Foundation—and the board approved expanding membership to new categories including donor-advised fund holders, giving circles, and individual philanthropists. An associate member category has been created for professional advisors.

## PEER CONNECTIONS In 2018, Colorado Association of Funders facilitated more than 85 hours of peer-to-peer learning and networking.

"To bring people, information and resources together to promote effective and responsible philanthropy in Colorado." Of the many ways we work to fulfill this mission statement (on the left), we've found peer groups and learning networks to be one of the most promising strategies. Meaningful connections between funders allows for sharing best practices, opportunities, and lessons learned; coordinating presence; and when appropriate, collaboration.

In 2018, we added three new peer groups:

The **Arts & Culture Funders Group** provides a space for funders to share projects, creative funding approaches, and opportunities to collaborate. In 2018, the group focused on brainstorming and researching trends in investments, partnerships, and collective funding.



The **Information Technology Roundtable** is a peer group for members interested in connecting with other foundation professionals about the latest in IT and cyber security. In the ever-changing landscape of IT, this peer group provides a supportive environment to exchange information and updates on best practices.



A core group of member foundations have invested in the creation of a network structure aimed at better serving the needs of rural communities and addressing pressing challenges in rural Colorado. With the hiring of a full-time director in late 2018, the Rural Funders Learning Network began convening regularly for active peer learning, networking, and sharing of information. Goals also include: identifying innovative approaches and funding strategies, while fostering partnership opportunities among funders. There is also the opportunity for funders to work together on the larger, systemic issues affecting rural Colorado. All funders are invited to participate in the effort, which is guided by an advisory committee that meets frequently and includes leaders from Aspen Community Foundation, Boettcher Foundation, Caring for Colorado Foundation, The Colorado Health Foundation, The Colorado Trust, Delta Dental of Colorado Foundation, Donnell-Kay Foundation, Gates Family Foundation, Great Outdoors Colorado, Orton Family Foundation and Telluride Foundation. In late October, Aspen Community Foundation hosted the first official network convening in Basalt, which featured learning about key data on the region and lessons learned on ACF's Cradle to Career initiative. A webinar in December attracted dozens of members wanting to learn more about how to play a role in supporting new Opportunity Zones.



## ADVOCACY & POLICY

Colorado Association of Funders continues to enhance its ability to advocate for the sector, receiving high marks in a national assessment of our capacity to work strategically in this key program area.

Among the accomplishments and activities this year:

- ▲ The Public Policy Committee and Board's backing of an annual policy agenda that included new positions in favor of a fair and accurate decennial census count and support for a variety of existing and new state tax credits;
- Annual address to funders by Colorado Gov. John Hickenlooper;
- The establishment of the Joseph Nord Ignat Memorial Endowed Fund (invested at Community First Foundation) whose proceeds will go toward supporting an annual policy-related activity for members;
- CEO testimony (along with other Member CEOs) at State Capitol in favor of legislation encouraging charitable giving;
- A joint advocacy day at the State Capitol in partnership with nonprofits organizations;

- ▲ Written comments to the IRS/Treasury on a multitude of pending rules related to donor-advised funds, as well as comments filed on regulations affecting existing Colorado tax credits that encourage significant giving to nonprofit organizations;
- ▲ Led diverse annual delegation of Colorado foundation executives to Washington for Foundations on the Hill visits with all of our Senators and Representatives in Congress. These meetings emphasized the sector's significant support of communities throughout Colorado, while also urging lawmakers to support the continued enforcement of current law that bars 501(c)(3) charitable organizations from endorsing, opposing or contributing to political candidates or engaging in partisan campaign activities.
